This position will have a 75% clinical commitment, and its primary focus will be clinical teaching of undergraduate veterinarians; and didactic and laboratory teaching in the veterinary program. This individual will have completed advanced clinical training and have a passion for equine ambulatory practice. The successful applicant must be able to communicate effectively, work collegially, and collaborate with people of diverse backgrounds.

The Equine Field Service section operates out of the Veterinary Medical Centre at the Western College of Veterinary Medicine provides both primary care and specialist services to equine patients in the Saskatoon area. The section carries out over 2,000 ambulatory visits per year and focuses on providing a high level of clinical service and a positive client experience.

The Veterinary Medical Centre at the Western College of Veterinary Medicine is a state-of-the-art facility serving western Canada as an AVMA and AAHA accredited hospital and referral centre. The Equine Field Service section is resourced with four fully equipped ambulatory vehicles; each with storage, heating and running water. Available equipment includes digital radiography, ultrasonography, endoscopy, and power floats.

Experience in equine practice and/or advanced clinical training are required. Participation in after hours on-call duty for the Equine Field Service section will be required. Applicants must have a proven commitment to high quality teaching and patient care. Applicants should have demonstrated an ability to succeed in a collaborative clinical and teaching environment. The successful candidate be compliant with the University of Saskatchewan policy for operating university vehicles. Excellent communication skills and teaching experience are required. This position has no research requirement, but collaboration in ongoing research projects will be encouraged. Salary for this position will be commensurate with the successful candidate's education and experience.
